## **POLICIES**

#### **Booking Policy:**

- Reservations for events must be made in advance.
- A non-refundable deposit *may* be required to secure the booking.
- Events are booked on a first-come, first-served basis, subject to availability.

#### Cancellation Policy:

- Cancellations must be made 7 days prior to the scheduled event.
- Deposits are non-refundable

#### Food & Beverage Minimums:

• A minimum spend requirement may be in place depending on the size of the party and the day/time of the event.

#### Food & Alcohol Policy:

- Outside food or beverage may be considered for your event only if it is preapproved, safe, and complies with all relevant health and liquor laws (as regulated by the Department of Alcohol and Tobacco Control).
- All beverages intended for consumption on our premises must be sourced from a legitimate distributor. Corkage fees will be applicable in such cases.
- Arrowood may offer a selection of alcoholic beverages for private events.
- The consumption of alcohol by guests must comply with local laws and regulations.

#### Decorations and Setup:

- Arrowood Golf Course does not allow décor to be stapled, nailed, or any other substances to by affixed to any wall, floors, pillars, or ceiling.
- No glitter, rice, confetti, sparklers, or fireworks permitted.

#### Service Charge and Sales Tax:

• A 22% service charge and applicable state tax will be added to all food, beverage, audio-visual charges, and room rental/location fee, ancillary items.

#### Payment Terms:

- Full payment for the event, including any additional services or charges, must be settled before or on the day of the event.
- Payment methods accepted include cash, credit/debit cards, or cashiers check.

#### Damages:

- The host is responsible for any damages caused to the Arrowood's property during the event.
- Flight Deck at Arrowood Golf Course reserves the right to charge for any damages incurred.

#### **Guest Conduct:**

- Guests are expected to conduct themselves in a respectful manner and adhere to the restaurant's policies and guidelines.
